At the recently held National Black Political Leadership Conference, two Black Presidential candidates, Dr. Willie Wilson and Ms. Sedinam Kinamo Christin Moyowasifza Curry were the featured luncheon speakers at this gathering of national, state and local political, spiritual and community leaders from across the country. This historic conference was convened by the Universal African Peoples Organization (UAPO) headed by long time human rights activists and founders, Zaki Baruti and Safiyah Chauvin. This two day event was held Friday, October 30th and Saturday, October 31st at Greater St. Mark Family Church, Ferguson, MO.

Tommie Pierson, MO State Representative and candidate for Lt. Governor of Missouri; MO State Representatives Kim Gardner and Rochelle Gray, Mayor Patrick Green, Normandy, MO; Mayor Yolanda Fountain-Henderson, Jennings, MO; Wesley Bell, Ferguson, MO City Councilman; Minister Donald Muhammad, Mosque 28; Rev. Multi-million dollar businessman, Dr. Willie Wilson, who hails form Chicago, IL was the keynote luncheon speaker on Friday. During his presentation, he outlined his vision and platform for this country, as well as how the major Democratic Party operatives have systematically prevented him from being part of their debates and forums. Many of the delegates were shocked by his revelations and pledged to make his candidacy known throughout the communities of America and to challenge the Democratic Party for their exclusionary policy toward the Black presidential candidate. Attending the workshops were members of the general public.

On Saturday, Ms. Sedinam Kinamo Christin Moyowasifza-Curry, a Los Angeles, CA resident who is seeking the Green Party Presidential nomination engaged the lunch time audience by seeking their input as to what they saw as the most important social issues that should be addressed by the 2016 Presidential

candidates. She also served on several of the powerful workshops held at the conference.

The purpose of the conference was to address the concept of "Proportionate Political Representation." This concept simply means that whatever percentage of the population of this country that we are as a people on the National, State and local levels of government, then we should have that percentage of political representation/power. However, it was pointed out that today, 2015 this is not the case. Black people are 13% of the US population, yet we are only 2-3% of the estimated 511,000 publicly elected officeholders and there are no Black Governors out of a total of 50 and only

two Black US Senators out of a total 100.

In response to these startling figures, the conference delegates agreed with the UAPO strategy of seeking Black men and women willing to become candidates in the upcoming 2016 national elections for the 34 US Senate seats and 11 Governors positions that will be up for election. Quoting Zaki Baruti "The most progressive political movement of the 21st Century is "Proportionate Political Representation." Also, the conference endorsed the proposal of Malik Zulu Shabazz for a National Blackout (only spend money with Black owned businesses starting with the upcoming Black Thursday holiday season and up until the new year. The conference attendees vowed to create a movement to support a national chain of Black owned products.

Finally, all of the delegates left the conference energized and committed to support a call for a National Black Political Convention for the last weekend in March, 2016. There will be a series of organizing public meetings prior to the convention. A special thanks to the UAPO central committee members Queen Ziah, Amari Sneferu, Gwen Cogshell, Robin Norman, Rev Elston McCowan, Safiyah Chauvin and all of the supportive UAPO general membership.

THE TASK AHEAD

THE MOST PROGRESSIVE POLITICAL MOVEMENT of the 21st Century **Building The National Black Political Movement To Achieve** "Proportionate Political Representation"

As stated on the front of our newspaper "the most progressive political movement of the 21st century is the "National Black Political Movement To Achieve Proportionate Political Representation." This concept simply means that whatever is the percentage of our people on the National, State and local levels of government, then we should have that percentage of political representation/power as a base line minimum.

However, as many of you know, sadly to say today, 2015: we are far removed from that vision of proportionate representation. When you examine the political statistics, we need to be skyrocketed into a whole new political reality in this country; especially in light of the fact that we pay our fair share of taxes.

It is criminal that we are 13% of the United States population, yet of the total estimated 511,000 publicly elected officials; we hold only 10,500 positions which is only 2% of the total. With proportionate Political Representation that number should be a minimum of 66,500 or 13%.


Today, out of 50 State governors, not one is Black, but with proportionate representation that number should be at least 6 or 7. In the powerful House of Senate, there are 100 Senators and only 2 are Black (2%); whereas we should have at least 13 or 13%. An example of our under representation on the local level of government was the community of Ferguson, MO which was the epicenter of rebellion against police violence and murder in 2014. Prior to the recent 2015 Ferguson city elections and at the time of Michael Brown Jr's. murder by killer cop, Darren Wilson on August 9, 2014, Ferguson's Black population was 64% Black. However, Ferguson's city council was comprised of six members and only one was Black. Therefore, as a political, social and economic consequence of that political reality; Ferguson Police Department had 54 police officers and only three Blacks were on the force. In essence, Black residents of Ferguson were financing through their tax dollars their own oppression per the racist police force. Throughout America, there are thousands of communities reflective of the political dynamics of Ferguson. That's why we must achieve "Proportional Political Representation."

The above example of Ferguson's political under representation speaks to the fact that with "Proportionate Political Representation," the economics of our community would be greatly enhanced. Most political offices pay a salary, accordingly our employment would increase and political offices influence employment of other city, state and federal workers.

A classic example of this factor was the employment and composition of the

Ferguson Police Department as cited above. Finally, political power directly affects public policy and the expenditures of our tax dollars on issues such as housing, education, health, domestic policy, foreign aid, etc. Given the above reality, it is the Universal African Peoples Organization's intent to build a movement to achieve "Proportionate Political Representation" through a National Black Political Empowerment Movement. We are committed to enacting both a short and long range plan for this movement. Our short range plan is composed of four phases.

1. Phase One -- Hold a National Black Political Leadership Conference which occurred on October 30-31, 2015. Over 100 delegates



- 2. Phase Two -- Convening a National Black Political Convention June 3-4 2016 in St. Louis, MO. At this convention our long range planning will be outlined and we will present our Black Federal and State Candidates. We will also host a Black Presidential Candidates Debate.
- 3. **Phase Three** -- Will comprise of Educating, Registering and Mobilizing our people to vote in the 2016 primary and general elections.
- 4. Phase Four -- After the 2016 November elections, reconvene the National Black Political Leadership Conference to evaluate our work. Date/Site TBA

Finally, as one more emphasis, it is our desire to have a team of capable and motivating candidates who will be challenging for the most important political offices of this country (the Presidency, US Senators and Governors) and they all are campaigning on the issues impacting our daily lives. Again, this action would be the "Most Progressive Political Movement of the 21st Century."

Spiritual Communities Role in Politics



2016 Black Democratic Presidential Candidate Dr. Willie Wilson Campaigned in St. Louis

Multi-Millionaire businessman, Dr. Willie Wilson visited St. Louis, Missouri on Sunday, November 22, 2015 at the invitation of the Universal African Peoples Organization (UAPO) headed by Zaki Baruti.







There were a series of activities that Dr. Wilson made appearances and he was well received. His first appearance was at Greater St. Mark Family Church pastored by Rev. Tommie Pierson. Dr. Wilson, a deacon at Christ Temple M. B. Church in Chicago, Illinois delivered the morning sermon, "Making the Right Choice When You Have a Choice".







After church service, Dr. Wilson toured the Canfield Green Apartments in Ferguson, Missouri and paid homage to the memory of Michael Brown, Jr. as he laid a Red, Black, and Green wreath at the slain youth's memorial site.

While there, he also held a press conference and detailed how an end to police violence would be a top priority of his campaign. He furthered called for an end to the mass incarceration of black youth and added that economic empowerment of our community is another priority of his campaign.







Leaving the Canfield Green apartments, his entourage went to have lunch at the renowned Sweetie Pies Upper Crust on Delmar Blvd. While there, he was met by many of his supporters and he shook the hands of the many patrons of the restaurant as he distributed campaign literature.







His final campaign stop was at Legacy Bookstore and Café, 5249 Delmar Blvd, where the UAPO held a well-attended public reception saluting his candidacy. The crowd was entertained by the Three Central Jazz Band. Dr. Wilson provided remarks about his platform and received a standing ovation.

Ex-Topekan Announces U.S. Senate Run As Part Of Effort To Increase Number Of Black Elected Officials

A former Topeka woman announced her candidacy for U.S. Senate on Tuesday as part of a nationwide effort to increase the number of black individuals in elected office.

Monique Singh-Bey, who now lives in Wyandotte County, will run for Senate as an independent as part of a push by the Universal African Peoples Organization, a national organization that promotes the concept of proportionate representation. The group wants the percentage of elected officials who are black to mirror the percentage of the overall population that is black.

In the Senate, proportional representation would mean about 13 senators out of 100 would be black. Currently, there are only two in that chamber.

"God has blessed me to be used as his vessel to become — to stand for our people," Singh-Bey

Singh-Bey is a long-shot candidate, but her focus on the black community may resonate amid ongoing national attention on problems and issues facing African-Americans. Since the death of Michael Brown in Ferguson, Mo., in 2014 at the hands of a police officer, the country has grappled with racial tension in a way not seen for years.

Those issues have included police interactions with African-Americans, as well as economic troubles. African-Americans are more likely to be in poverty and more likely to be in prison than whites.

"We're calling for what we call community control of police departments. What does that mean? It means police departments are to reflect the ethnicities of the communities in which they work," said Zaki Baruti, leader of the Universal African Peoples Organization.


At the announcement of Singh-Bey's candidacy outside the federal courthouse in Topeka, Baruti also drew attention to "redlining." In redlining, residents in certain areas of cities with large minority populations are denied services or charged higher prices.

Singh-Bey, who works as a valet and also has been a court advocate, invoked her family's past in speaking about her candidacy. Her grandmother was one of the plaintiffs in the landmark Brown v. Topeka Board of Education lawsuit.

Tuesday marked the 60th anniversary of Rosa Parks' refusal to give up her seat on a bus in Montgomery, Ala., a move that sparked the Montgomery Bus Boycott. Baruti cited the occasion during the announcement, and said he

would be introducing candidates in additional states.

Republican Sen. Jerry Moran faces re-election in 2016. As of July, his campaign had more than



Speculation had swirled around whether Milton Wolf, a Leawood radiologist, would challenge Moran for the Republican nomination. Wolf unsuccessfully challenged Sen. Pat Roberts in 2014, mounting a tea party-style challenge.

But earlier this fall, Wolf filed paperwork to terminate his campaign committee. The move has been interpreted as a sign Wolf doesn't plan to run.

"You don't close one of those committees unless you're done," Chapman Rackaway, a political science professor at Fort Hays State University, said at the time.
