### Two Prominent Black Political Activists and Owners of the Green Duck Lounge Are Commemorated (They Were Murdered In Kansas City, MO)

On Monday, July 15, 2019 the Universal African Peoples Organization (UAPO) in conjunction with the International Black Hat Society headed by local Kansas City community activist, Ms. GG Owens held a commemorative program saluting the legacy of two prominent Black Entrepreneurs and political activists, Mr. Leon Jordan and Mr. Jimmy Townsend. The program was held in front of the now vacant Green Duck Lounge located at 2548 Prospect Avenue, Kansas City, Missouri.

Mr. Leon Jordan, a very outspoken political activist who founded the well-known organization, Freedom Incorporated and who also owned the popular Green Duck Lounge was shot and killed on July 15, 1970. Although his murder was never solved, according to an article printed by the Kansas City Star Newspaper; the police and different news sources speculated that his assassination was the result of a group called the Black Mafia with support from white mobsters. # The Universal African Peoples Organization (UAPO) Stands In Solidarity With The Social Justice Reforms of Kim Gardner – St. Louis 1st Black Elected Circuit Attorney

On Thursday, June 27, 2019, the Universal African Peoples Organization (UAPO) along with other progressive organizations and individuals held a solidarity rally in support of St. Louis' 1st Black elected Circuit Attorney, Ms. Kim Gardner. This rally was held in front of St. Louis City Hall and over 150 people participated.

Remarks supporting Ms. Gardner were made by different activists including Ticharwa Masimba, African People Socialist Party, Adolphus Pruitt/-NAACP, Linden Bowie/Missouri Baptist State Convention, Attorney Jerryl her." Eventually, because of other allegations Greitens resigned as Gov-Christmas, Jamala Rogers/Organization For Black Struggle and Zaki Baruti/Universal African Peoples Organization.

Also, in attendance were the Moorish Science Temple of America led by Todd El, the Taheed Youth Organization headed by Anthony Shahid, Donald Muhammad/Nation of Islam, Mosque Safiyah Chauvin/UAPO, former U.S. Senate candidate Coffee Wright, activistsWillie Boyd, Walle Amusa, Kunama Mtendaji, Rev. Phillip Duvall, Amir Brandy and long-time human rights activist Percy Green.

After the remarks and rally, there was a March around City Hall led by Zaki, whereby the Thursday evening rush hour was disrupted.

These attacks were further intensified when in February 2018, she pursued litigation against the then Governor of Missouri, Eric Greitens; a so-called rising star in national Republican politics.

She infuriated the "white powers to be" with her leading an effort to indict Greitens on a charge of felony invasion of privacy, which was an extension of a woman claiming that Greitens had coerced her into having sex and that he later slapped her. Given the boldness of her action, Ms. Gardner was threatened by Greitens' attorneys that they would "destroy ernor of Missouri.

Also, the predominately white St. Louis Police Association has consistently attacked her character, because Ms. Gardner had the audacity to place on an exclusionary list developed by her office of over fifty officers (mostly white) that she will not take any evidence from them for any trial case, because of their shady actions and history.

Because Ms. Gardner has stood up for the Black community and has come under vicious attacks, the progressive forces of St. Louis have come together to create the Community Justice Coalition. This coalition includes the Coalition of Black Trade Unionists, the St. Louis City Chapter of the NAACP, Missouri Baptist State Convention,

Organization For Black Struggle, St. Paul AME Church, StL Real News, Block 302 and the Universal African Peoples Organization (UAPO).

ing the Office of the Circuit Attorney by addressing the issue of mass incarceration with alternative diversion programs and holding rogue police officers accountable for their actions has come under serious attacks from the reactionary "white powers to be" in the St. Louis Region.

Ms. Gardner who was elected in 2016 on a progressive platform of reform- Finally, the UAPO has a rich political history in supporting progressive candidates in the past for the position of Circuit Attorney prior to Ms. Gardner's election. These candidates included Elbert Walton, Donnell Smith and Jerryl Christmas. So, it is in the spirit of "Proportionate Political Representation" and the powerful spirit of Circuit Attorney Kim Gardner, that the Universal African Peoples Organization supports her wholeheartedly in her pursuit of "Social Justice Reforms."



### Supporting Social Justice Reforms

One of the major issues that many community activists from across the country have consistently called for in response to police violence and mass incarceration has been social justice reforms. This Rallying call has been a fervent issue here in St. Louis and throughout the nation for many, many years.

These social justice reforms have included calls for Black Community control of the police, civilian review boards for police departments, prosecuting and convicting murderous and rogue police officers and putting to an end the policy of locking up masses of people for nonviolent crimes which helps fuel mass incarceration.

In response to the calls for social justice reforms, there have been many different approaches which have included countless rebellions such as the Ferguson uprising, street justice against the police as evidenced by the shooting deaths of five Dallas police officers by Micah Xavier Johnson and utilizing the political process of electing progressive candidates who support the above reforms.

Accordingly, here in the St. Louis region, we have been able to elect for the very first time two capable individuals who have pledged and are willing to implement the types of social reform justice that will benefit our community.

The two who were elected in the aftermath of the Ferguson Uprisings are Kim Gardner who in 2016 was elected St. Louis City's First Black Circuit Attorney and Wesley Bell, who in

2018 was elected St. Louis County's First Black Prosecuting Attorney.

Both positions have a tremendous impact on whether "justice is color blind" or "just us." Immediately upon their election, they both have come under variousforms of attack.

Upon Wesley Bell taking office, a number of attorneys from the previous administration of racist Bob McCulloch immediately joined the St. Louis Police Association which has its own history of racism.



Ms. Kim Gardner who prosecuted killer cop Jason Stockley, but lost the proven case due to racist judge Timothy Wilson's decision has proven she means business when it comes to her efforts of implementing social justice reforms.


These reforms have included (1) her leading the effort to indict a sitting Governor, Eric Greitens (2) excluding testimony/evidence from over fifty rogue police officers and (3) creating a diversion program as an alternative to locking up nonviolent offenders. For her actions, she has come under vicious attacks from the "powers to be."

If our community have public officials willing to make social justice reforms that benefit our community; then it is Common Sense that we should wholeheartedly support them!! 



### King Kong of Terrorism

UAPO Foreign Minister's Report: (A Critique of U.S. foreign policy / by (Seba) Amari Sneferu)



The countries of Iran and Venezuela are in the cross hairs of U.S. foreign policy. As a result, Black folks want to know; what's the nature of these conflicts? Do they affect us? Where should we stand on these issues and why is the United States hell bent on using our hard earned tax dollars, to subvert and terrorize these foreign countries? "Now Seba Amari, did I hear you say terrorize?" Yes, I absolutely did. The United States of America is the King Kong of terrorism; trouncing its wicked agenda with more than 800 military bases throughout the world. Clothing a ruthless White Supremacy under the veil of "American Exceptionalism", the United States adopts the same ole propaganda narratives for "regime change", whenever it wants to justify the overthrow of a sovereign nation.

When we look at the history of U.S. intellectuals on the subject of this country's exploits here in the western hemisphere, in the Middle East, in Africa or anywhere in the world; genocide denial is the prevailing pathology. It's the hidden white elephant behind the curtain that contradicts its own ill crafted message every time it moves. Case in point: "Saddam Husain is hiding weapons of mass destruction" or "Muammar Gaddafi of Libya and Bashar al-Assad of Syria are both killers of their own people." Shortly following this propaganda; the U.S. military invades another country and 460,000 Iraqis die directly or indirectly as a result. The United States led NATO invasion of Libya resulted in more than 50,000 Libyans dead followed by a reinstitution of an impromptu Arab slave trade. Yes indeed; Africans are being bought and sold as slaves in Libya today. And yet another tragic example: 400,000 Syrians have died mostly as a result of the CIA's secret war; falsely characterized today as the Civil War in Syria.

Unbeknownst to many Black folks; the United States has a long legacy of terrorism in its foreign policies. In many ways it mirrors the shameful domestic history regarding its so-called citizens of African descent. Woodrow Wilson, the nation's most extreme racist among U.S. presidents, invaded Haiti and killed more than 20,000 Haitians. Right here on the home front, President Wilson segregated the federal government and reversed years of civil rights advancements gained during reconstruction. Upon taking office, he fired Black supervisors across the board in the Federal Services and replaced them with white folks. During his administration; the Department of Treasury and the Post Office Department both introduced screened off workspaces. And when a Black individual worker who could not be separated in the office due to job necessity; a cage was literally built around him to separate him from his white office companions. A few years prior to that, here in the western hemisphere under the leadership of Teddy Roosevelt and a wealthy French business man, Philippe-Jean Bunau-Varilla; the U.S. stole land from Columbia and created the nation of Panama in order to build the politically lucrative Panama Canal.

Even President Jimmy Carter the so-called human rights President, is not unstained of terrorist policy. In 1978 during the peak of Indonesian atrocities when the U.S. Congress imposed human rights restrictions blocking the flow of advanced weaponry, President Carter created a side door policy and found a way to get Israelis to send sixteen U.S. (Skyhawk) aircrafts to Indonesia. This enabled the Indonesian government to complete the genocide of nearly a quarter of a million of its own communist leaning citizens (So much for American disdain for leaders that kill their own people). Another example shortly followed when President Ronald Reagan who came into office claiming that the war against international terrorism would be the core of his foreign policy; Reagan actually created the largest international terrorist network the world had ever seen. It was so bad that the United Nations condemned the United States essentially for international terrorism; for the Unlawful Use of Force in Nicaragua. President Reagan in defiance; responded by immediately escalating the war by including a strategy of mercenary army attacks upon so-called soft targets (un-defended civilian targets). With impunity; these target attacks included agriculture collectives, health clinics and the like. This super power terrorist assault upon a small country was designed to destroy their infrastructure and wreck their economy. The intended strategy was to force the poor exhausted citizens to overthrow their own government or support a U.S. backed candidate in the next election. Behind the plastic veil of phony democracy; this is the United States of America for what it truly is (a vicious bully on the world stage). This CIA backed proxy war labeled "Iran-Contra" was financed with secret arm sales to Iran and secret CIA cocaine trafficking to the Black community in South Central Los Angeles. An estimated 30,000 Nicaraguans were killed in the CIA's Contra war against the Sandinista government of Nicaragua.

This is the historical backdrop that tragically prevails behind a King Kong nation; drunk on wealth and military power; wreaking havoc onto smaller, less powerful nations. Democratically elected leaders are not safe, i.e. the two failed attempts by the United States to over-throw the Democratic Socialist government of Venezue-la. August of 2017 President Donald Trump drastically intensified economic sanctions that were already in place against this country. Disproportionately hitting the most vulnerable (Afro-Venezuelans), these sanctions have inflicted very serious harm including more than 40,000 deaths just from the period of 2017 to 2018 not

to mention that of 2019. The U.S. mercilessly wants control of the 297 billion barrels of Venezuelan oil; the largest oil reserves in the world.

It's the legacy of the Universal African Peoples
Organization, to speak truth to power. However it is
even more important to speak truth to the powerless
in order to empower the people with information that
will help set us free. Whether it's the war policies of
Bush 1, or the war crime policies of Bush 2, or even
the terrorist policy of Bill Clinton, who sent fourteen
Cruise Missiles into the Sudan to destroy a pharmaceutical plant; pain and destruction is always the outcome. This pharmaceutical plant specializing in Anti-Malaria drugs was the largest manufacturer of
medicines in all of Sudan. The propaganda narratives
are always one thing while the strategic objectives
are usually a hidden U.S. policy of terrorism and aggression for the ultimate control of other folk's
resources.

June 20, 2019 Iran's Revolutionary Guard shot down a United States surveillance drone with a Surface-to-Air missile over the Strait of Hormuz 6,000 miles from American soil. The U.S. accused Iran of trying to provoke a war. July 24, 2019 a U.S. Navy war ship allegedly shot down an Iranian drone of which Iran denies being hit at all. Whatever the case, how can someone accuse someone else of provoking a war with them, when it is they that pulled their proverbial car up into your driveway? These fake narratives are an insult to our intelligence. Simply put; the U.S. wants war with Iran for the control of oil in their region (in their proverbial driveway) and to block Iran's economic plans for abandoning the use of the American Petrodollar.

Why should we as an African people endorse these policies and swallow these false narratives, especially in light of our experiences under slavery, Jim Crow, growing wealth gaps, mass incarceration and racist waves of police shootings aka "Blue Terrorism". Why should we allow ourselves to be manipulated by the same government that manipulated and betrayed the so-called citizenship rights of our ancestors? Perhaps true citizenship for Black folks in America is also a false narrative we've yet to fully dissect in light of our suffering. I suggest we take an anti-war position and refuse to enlist into any military wing of the United States Government. From now on; if there's a fight to be had that includes us, let it be for a just cause; let it be for our own liberation. From now on, let's show the world how to stand up to the bully. Let us come together and speak with one voice. It is then we will be able to say with true meaning: KING KONG AIN'T GOT NOTHING ON ME !!!



## Are the Police Departments Across America Color Blind? By Deacon JB Bond

Since the inception of the police force, police brutality against people of color has certainly been part of its format. The police force was started sometime after the Civil War to control the so-called wayward Negroes. Wayward is the term whites, in authority, coined for Blacks who spoke up against the contradictions, double standards and downright mistreatment of their civil rights. Just to keep the record straight, many other races of people have had their clashes with the police force also. The Irish, Jewish, Italians and other European ethnic groups had their challenges with the police force in the early 1900's. But their skin color did not prohibit their ability to climb up the social prominence ladder. They were not seen as threatening; therefore, they could not only join the police force, but were willing to participate in brutal acts. The African American could also climb up the social prominence ladder, but because of his or her skin color, could never be seen as non-threatening by white police officers. It is amazing to me how Black men are given supernatural abilities by white police officers when the officers go before the courts, media or judge. These officers imply that Black men have supernatural abilities to explain why the use of deadly force was necessary on Black young men who had no weapons at all.


Here are three well known cases of non-threatening Blacks who lost their lives because of their skin color. Betty Shelby, an officer of Tulsa, Oklahoma, shot and killed Terrence Crutcher because she said he was reaching into his SUV, and she feared for her life. Mr. Crutcher had his hands up the whole-time. The window of his SUV was up, and he could not have reached into it to get anything to harm the officer. All of this was on the police dash cam and she lied anyway.

Philando Castile was shot to death by officer Jeronimo Yanez in Falcon Heights, Minnesota during a
traffic stop of which Mr. Castile told the officer he
had a concealed license permit to carry a weapon,
While complying with the officer's first command
to see his driver's license, he was shot. Mr. Castile
was shot several times while reaching for his
wallet. Mr. Philando Castile's girlfriend and daughter were in the car with him when this happened.
Officer Yanez was on the driver's side of the vehicle and his partner was on the passenger side of the
vehicle during the traffic stop. Did Officer Yanez
think Mr. Castile would shoot him and the other officer and safely flee the scene with his family in
tow. Talk about supernatural ability.

Eric Garner was choked to death by police officer Daniel Pantaleo, who used an illegal chokehold to subdue Mr. Garner. Mr. Garner was non-combative and was heard several times saying, "I can't breathe! I can't breathe!"

When the shoe is on the other foot, as the cliché goes, a Black man is held accountable for his ac-tions as a police officer. Minneapolis Police Officer Mohamed Noor shot and killed an unarmed white Australian woman named Justine Damond, who made a 911 call to report a disturbance behind her house. The three previous officers were white, and the victims were Black. Neither of the 3 white officers were found guilty. Officer Mohamed Noor, who is Black, was charged and found guilty. The question begs to be asked, "Are the police departments across America color blind?" You have read evidence, so what do you think?

The king James Bible puts it this way: "You should know them by their fruits. (Matthew 7:16)" We must continue to always speak Truth to power, and remember Dr. King's quote, "The are of the moral universe is long, but it bends toward justice."

### **A Salute To Marcus Garvey**

"We are the descendants of a suffering people; we are the descendants of a people determined to suffer no longer. We shall now organize the 400,000,000 Negroes of the world into a vast organization to plant the banner of freedom on the great continent of Africa. We do not desire what has belonged to others, though others have always sought to deprive us of that which belonged to us...

The above powerful prophetic statement made by the Honorable Marcus Mosiah Garvey to over 25,000 Blacks gathered at Madison Square Garden in New York on August 2, 1920 was simply a glimpse into the magnificent vision of one of the most brilliant Pan – Africanist organizers, thinkers, and orators during the 20th Century. The occasion for his remarks was the international convention of Black people from throughout the world, which was sponsored by Garvey's organization, The Universal Negro Improvement Association.

It was on August 1, 1914 in Jamaica, Garvey's birthplace, he and Amy Ashwood had the foresight, tenacity and dedication to found the expansive Universal Negro Improvement Association and Conservation Association and African Communities League. In 1916, he moved to the United States and a year later began the First Chapter in New York, where he eventually maintained his headquarters.

Coming into a post-World War I environment in which our people were facing constant lynchings, race riots, entrenched racism on all levels of the United States Society, Garvey filled a leadership vacuum. From 1919-1920 his call for unity among Black people throughout the world began a period of remarkable, unprecedented and even today unmatched growth of his organization's membership which eventually reached 4,000,000 Blacks.

One of the important reasons for Garvey's amazing success was his establishment in 1918 of the Negro World, his organization newspaper. Within a space of a few months, the Negro World became one of the leading black weekly's with an estimated circulation between 60,000 to 200,000. The structure of the newspaper was interesting. Separating the two words, Negro and World was a sphinx – like seal bearing the motto of the organization, "One Aim, One God, One Destiny." Under this was a phrase, "A Newspaper Devoted Sorely To The Interests of the Negro Race." Certain sections of the newspaper were printed in French and Spanish for the benefit of those Caribbean based Blacks who could not read English. The front page of the paper always carried a lengthy editorial proudly addressed to the "Fellow Men of the Negro race and signed, your obedient servant Marcus Garvey, President – General."

These editorials covered a wide range of subjects, ranging from grand visions of the past glories of Black History, the stirring heroism of leaders of slave rebellions, such as, Denmark Vessey, Gabriel Prosser and Nat Turner, the struggle of Zulu and Hottentot warriors against European rule, Queen Yaa Asantewa of Ghana struggle against the British and the history of Moorish and Ethiopian empires. The paper also made promotional appeals on behalf of the organization and carried news of the activities of the various divisions and branches of the Universal Negro Improvement Association

In 1919, Garvey's organizational activities had progressed enough for him to purchase a large auditorium located at 114 West 138th Street, in Harlem. This facility had a seating capacity for as many as 6,000 people and was named Liberty Hall. It served as the American headquarters for his organization.

Marcus Garvey's determination to overcome the economic strangle-hold that the white world held over Blacks led him to break the monopoly of the white dominated maritime industry through the creation of the shipping company, Black Star Lines in 1919 and the Black Cross Navigation and Trading Company in 1924. Thus, his organization was able to purchase four steamships, the S.S. Yarmouth, S.S. Shadyside, S.S. Kanawha and the S.S. General G. W. Goethals. This extraordinary feat was a great and proud achievement that the masses of Blacks glorified.


A further example of Marcus Garvey's vision included his establishment of another business enterprise, the Negro Factories Corporation. Capitalized at \$1,000,000 under a charter from the State of Delaware, the corporation offered 200,000 shares of common stock to Blacks at a value of \$5.00 per share. The purpose of this company was to build and operate factories in the big industrial centers of the United States, Central America, the West Indies and Africa to manufacture every marketable commodity. Among the businesses developed by the corporation were a chain of cooperative grocery stores, a restaurant, a steam laundry, a tailor and dressmaking shop, a millinery store and publishing house.

In 1924, Garvey created another Universal Negro Improvement Association venture, the Negro Political Union which was designed to consolidate the political forces of Blacks through which the race could express its political will. With his customary vigor, Garvey pushed the activity of the Negro Political Union in the 1924 American elections, issuing a nationwide list of approved candidates. The most ambitious Plan – Africanist undertaking started by Marcus was his "Back to Africa movement." This concept was to recolonize our people in Liberia because of the strident racism in the United States and his dream of redeeming Africa through its children lost during the diaspora.

Other aspects of his organization included the African Legion, which served as a security wing and the Black Cross Nurses formed to help the stricken and less fortunate. One of his last projects was The Black Man, a monthly magazine started in 1933.

Due to his tremendous ability to galvanize and organize masses of our people, the United States government charged and tried and convicted Marcus Garvey on a dubious mail fraud charge in 1923. While in jail, he continued to organize. Finally, the President Coolidge pardoned him on the condition of Marcus Garvey being deported from the United States which occurred in 1927.

The significance of Marcus Garvey lies in his appeal to the dreams of millions of Blacks throughout the world and can be summed up in his own words:



"If we must have justice, we must be strong. If we must be strong, we must come together;

If we must come together, we can only do so through the system of organization. Let us not waste time in breathless appeals to the strong while we are weak but lend our time, energy and effort to the accumulation of strength among ourselves by which we will voluntarily attract the attention of others....

Up You Mighty Race – You Can Accomplish What You Will."

# UAPO Outreach Committee Continues its Work to Uplift Our Community

The Universal African Peoples Organization (UAPO) Outreach Committee headed by Gwendolyn "Imani" Cogshell continues its determined efforts to address a few of the multiple issues impacting our communities. Organized in 2015, this committee has led the way in our adoption of Walbridge Elementary School, St. Louis Mo. With the adoption of the school, the committee has each year organized campaigns to provide over 200 students with necessary school supplies such as notebooks, pencils, paper, book bags, etc.; as well as personal hygiene products and clothing items. In helping the students, the Committee has also sponsored back to school haircuts.

Also, in 2017 responding to the kidnapping and sexual assault of a young female student on the way to school, Imani led the way in creating the UAPO Neighborhood Patrol. The Patrol's responsibility was to be vigilant and watchful in the early morning hours, as students walked and waited for their school buses. Part of the Patrol included parents who wholeheartedly welcomed the idea. The Committee was able to meet with St. Louis Public School officials and were able to get some school bus stops changed because of the proximity to dangerous areas and were able to get students put into groups at bus stops for safety precautions.

As a pioneer of the concept of watching out for our children, and the fact many children are falling prey to predators, the committee extends its congratulations to another progressive organization with greater resources, Better Family Life for adopting the idea and expanding the concept through its Neighborhood Net Program. Finally, on June 9, 2019 the Committee sponsored a clean-up campaign in the historic O'Fallon Park. The primary objective was to encourage our people to take pride in our communities utilizing the slogan "Cleanliness Is Next to Godliness."

But, unfortunately earlier this year, I was contacted by state prison officials that "someone had dropped the ball" concerning W. Claybon who had pled guilty to Malik's murder and that he could not be considered for parole until 2046.

However, to my dismay that date has been moved up to 2032, OMG!!! Even though there is no out date, as Malik's mother, I must continue to stay resourceful on my son's behalf, to keep this murderer from killing someone else's child.

Malik's birthday was October 7, 1985 and he came into the world weighing a whopping 11 pounds, 12 ounces and 26 inches long through natural birth. 

# Two Prominent Black Political Activists and Owners of the Green Duck Lounge Are Commemorated

(They Were Murdered In Kansas City)

After the Green Duck Lounge had been closed a number of years following Mr. Jordan's death, in 1997 Jimmy Townsend purchased the building. Mr. Townsend also owned several other properties throughout Kansas City. However, on December 18, 2015, the beloved 83-year-old Jimmy Townsend was also shot and murdered. There has been much speculation about the motives behind his death but to date, no one has been charged.

For many, the Green Duck was a gathering place for the Kansas City political activists.

In the backdrop of these two high profile killings, Ms. GG Owens appealed to the UAPO headed by Zaki Baruti to hold the commemorative program.

Prior to holding the program, a press conference was held to vigorously call for reopening the investigation into Mr. Townsend's death, as well as for over seventy unsolved murders in Kansas City this year.

A number of Kansas City activists were in attendance and they included Ron McMillan, Evaline Taylor, Marva Etier, Sonny Gibson, Teresa Perry, LaMarr Vickers and Maurice Copeland. Also, present were family members of Mr. Townsend headed by his daughter, Deloris LaBlanca.

In concluding the program and in remembrance of Mr. Leon Jordan and Mr. Jimmy Townsend, there were Red-Black and Green balloons released in their honor. Finally, Kansas City activists have begun an effort to re-open the Green Duck Lounge which has been placed on the Kansas City historic registry.


